No. 114307/OB-945 dated: 17/12/2015 including those arising from orphaned products. Provided the collection centers established by producer can also collect e-waste on behalf of said recycler including those arising from orphaned products.

- (2) Ensure that the facilities are in accordance with the standards or guidelines issued by Central Pollution Control Board from time to time;

PUBLIC NOTICE TO BULK CONSUMERS UNDER E-WASTE (MANAGEMENT) RULES, 2016

Whereas, the Ministry of Environment, Forest and Climate Change, Govt. of India in exercise to powers conferred by Section 6, 8 and 25 of Environment Protection Act, 1986 and in supersession of E-Waste (Management and Handling) Rules, 2011 vide G.S.R. 338(E) dated 23.03.2016 formulated E-Waste (Management) Rules, 2016. Whereas, these rules are applicable to every Manufacturer, Producer, Consumer, Bulk Consumer, Collection Centres, Dealers, E-retailer, Refurbisher, Dismantler and Recycler involved in manufacture, sale, transfer, purchase. collection, storage and processing of e-waste or electrical and electronic equipment listed in Schedule-I, including their components, consumables, parts and spares which make the product operational.

Whereas, under Section 3(c) of said rules, "Bulk Consumer" means bulk users of electrical and electronic equipment such as Central Government or State Government Departments, public sector undertakings. banks, educational institutions, multinational organizations, international agencies, partnership and public or private companies that are registered under the Factories Act, 1948 (63 of 1948) and the Companies Act, 2013 (18 of 2013) and health care facilities which have turnover of more than one crore or have more than twenty employees.

Whereas, under Section 9(1), consumers or bulk consumers of electrical and electronic equipment listed in Schedule 1 shall ensure that e-waste generated by them is channelized through collection centre or dealer of authorized producer or dismantler or recycler or through collection centre or dealer of authorized producer or dismantler or recycler or through the designated take back service provider of the producer to authorized dismantler or recycler.

Further, all E-waste generated by bulk consumers, after end of life should be sold to only authorized E-waste collection centre, recycler, dismantler and refurbisher as per provision of E-Waste (Management) Rules, 2016. List of E-waste items generated by the Bulk Consumers is mentioned in Schedule-I of E-waste (Management) Rules, 2016 and can be downloaded from the H.P. State Board website link https://hppcb.nic.in/.

Whereas, under Section 9(2) bulk consumers of electrical and electronic equipment listed in Schedule I shall maintain records of e-waste generated by them in Form 2 and make such records available for scruting by the concerned State Pollution Control Board.

Whereas, under Section 9(4) "Bulk Consumers" of electrical and electronic equipment listed in Schedule-1 shall file annual returns in Form-3, to the concerned State Pollution Control Board on or before the 30th day of June following the financial year to which that return relates,
