In continuation of notification ref. no. 68-72

- , it is further notified for all concerned that -
- 1. Distt. Body Hamirpur shall host, provide hospitality and convene the Annual General House of HPCSLA in liaison with State Finance Secretary Sh. Anurag Thakur Ji.
- 2. Distt. Body Hamirpur shall provide financial/other requirement to State Finance Secretary and the amount or other sanction /approval shall be given by State Executive Body.
- 3. All Distt. Bodies shall summarize their points regarding Objectives and works done and suggestions, if any, by them so as to represent in General House which shall be discussed and resolute as per the consensus of General House. All state Executives shall also prepare and summarize as per requirement of profile concerned.
- 4.If in extreme exceptional circumstances, State or Distt. executive fails to attend the house, he /she must have to provide representative on their behalf. If representative is provided from left members of respective State /distt. Executive body then replaced member needs to provide representative from respective State /Distt. Council outside of body. It is desired so as to fulfill the strength and complete the Quoram of House.
- 5. All Distt. Bodies need to widely circulate the dates and venue and motivate all members of HPCSLA to join the house.
- 6. Although special invitees have been invited vide notification referenced above but still all Special Invitees (either state /distt.) shall be personally intimated by the concerned present distt. body of that distt.
